

**Town of Springdale  
Tax Structure 2022**

At a meeting of Council held on December 13, 2021 the following rates and charges were approved pursuant to the terms of the Town's 2022 Budget are hereby published in accordance with the provisions of Section 109 (1) of the Municipalities Act.

Note:

**There will be a 2% Discount on property, business, poll, water and sewer taxes for citizens if paid in full by March 31, 2022.**

1. Section 112 of the municipalities Act – Real Property Tax of 6.75 Mills on the assessed value of the property. Minimum Tax is \$350.00.

Real Property Tax of 4 Mills on the assessed value of waterfront sheds and wharfs.

**5% Discount on property tax for Senior Citizens if paid in full by March 31, 2022.**

2. Section 120 of the Municipalities Act – Business Tax

Minimum Business Tax - \$350.00

Minimum Home Base Business Tax - \$350.00

160 Mills on the assessed value of the property for Banks and finance Companies

67.5 Mills on the assessed value of the property for Oil Companies

10 Mills on the assessed value of the property for Hotel & Motel

22.5 Mills on the assessed value of the property for Funeral Homes

22.5 Mills on the assessed value of the property for Professional Office and Drug Stores

20.5 Mills on the assessed value of the property for Beauty Salons and Barber Shops

10.5 Mills on the assessed value of the property for Private Schools and Colleges

Utility Companies and Cable T.V. Companies – 2.5 % of 2021 Gross Revenue

15.5 Mills on the assessed value of the property for businesses other than the ones listed above

\$350.00 Minimum for Day Care Centers

Business that have no real property assessment an Annual Tax Rate of \$1000.00 or ¼ of 1% of Gross Revenue whichever is lesser to a minimum of \$200.00. The tax is to be based on the previous year's gross sales.
